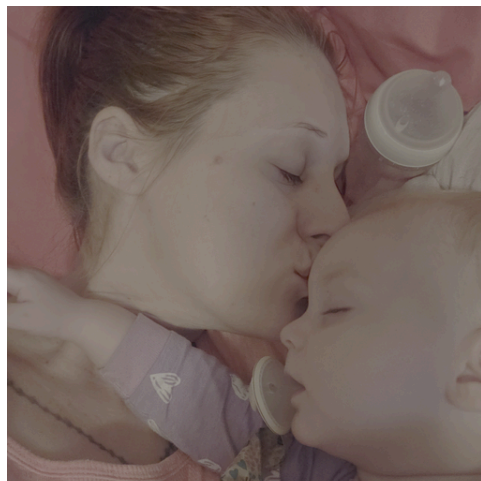

Finding Hope in South Carolina

Separated after fifteen years of marriage, JoAnne found herself with two children to care for on her own. She soon began a new relationship with a man who showed her affection and care, and discovered that she was pregnant. The father of this little one left as well, leaving JoAnne feeling alone and scared.

"I was devastated," relayed JoAnne. "I could barely take care of myself and my two children. I felt ashamed, afraid, and certain that I had ruined everything. The shame was so heavy that I convinced myself the only way to fix things was to end the pregnancy."

Abortion drugs in hand, JoAnne contemplated whether this was the right thing to do. The father, though still absent, didn't want to lose the baby either, causing more questions to arise for JoAnne. That's when she sought the help of a local church, which connected her to Daybreak LifeCare Center.

After feeling the heartfelt care of her contact at Daybreak, Tiffany, JoAnne made an appointment. "At that first appointment, they asked about my faith," she said. "Then they gave me a pregnancy test and performed an ultrasound. The moment I saw the tiny body on the screen and heard that heartbeat – steady and strong – I broke down crying. I knew right then: I couldn't go through with the abortion."

Daybreak cared for JoAnne as she walked through her pregnancy. As she began to put her life back together, obtaining a job, finding a home, and earning Baby Bucks through classes at the center, JoAnne felt that she was given a second chance ... a blessing.

A sweet little girl was born in the midst of all this change. Soon after, JoAnne experienced some medical scares, including severe mastitis, and had to undergo several surgeries to remove masses found in her breast. One was discovered to be cancerous. Her physicians were able to remove it before it spread. Reflecting on the life of her daughter, JoAnne shared, "If I had gone through with that abortion, they never would have found the cancer in time. My daughter saved my life – in every way a person can be saved."

- Value of services is based upon materials and services provided by 33 pregnancy centers in the state of SC in calendar year 2024. At least 10 of the centers reporting data received state or federal funding in 2024.
- Total savings are calculated based on cost estimates of services, classes and baby items provided to clients. The sources for the cost estimates and valuation of items and services can be found in the Methodology section of the 2024 CLI national pregnancy center report, "Pregnancy Centers: Rising to the Occasion with Unwavering Care" (<https://lozierinstitute.org/pcr/>), except for the following state-specific labor costs.
- The South Carolina mean hourly wages referenced are as follows: Social Workers in local/state government is \$40.73 per hour - BLS OES code 21-1029, Registered Nurses is \$40.83 per hour - OES code 29-1141, and Diagnostic Medical Sonographers is \$38.48 per hour - OES code 29-2032.
- The estimated savings does not include housing and other monetary assistance provided to some clients. We advocate for our clients by networking with hundreds of county, state and non-profit social service organizations around the country. We cannot quantify the value of emotional support given to the women we help through phone calls and caring volunteers.
